



## Vhi Facebook Competition Terms & Conditions

1. This promotion is open to residents of Republic of Ireland aged 18 or over except employees of the Promoter, their families, agents or anyone professionally connected with the promotion
2. To enter, visit Vhi Women's Mini Marathon Facebook page (<https://www.facebook.com/VhiWomensMiniMarathon/?fref=ts>) and follow the instructions on the Facebook post.
3. The opening date for entries is from the time the post goes live and the closing date for receipt of entries is 72 hours from the time the post goes live.
4. The promotion is limited to one entry per person
5. No applications from agents, third parties, organised groups or applications automatically generated by computer will be accepted. No incomplete or corrupted entries will be accepted. Entries will only be accepted if they comply with all entry instructions.
